Introduction

Vinegar is defined as a liquid fit for human consumption and contains a specified amount of acetic acid and water. It is produced from raw materials of different agricultural origin containing starch and sugars that are subjected to a process of double fermentation, alcoholic and acetous.

Vinegar is an acid liquid produced from the fermentation of ethanol in a process that yields its key ingredient, acetic acid (ethanoic acid).



The acetic acid concentration typically ranges from 4% to 8% by volume for table vinegar and up to 18% for pickling. Natural vinegars contain small amounts of tartaric acid, citric acid, and other acids. Vinegar has been used since ancient times and is an important element in European, Asian, and other cuisines. There are many different types of vinegars. The classification is usually based on the raw material used for its production. Malt vinegar, Wine vinegar, Apple cider vinegar, Balsamic vinegar, Fruit vinegar and many other types of vinegar exist in today's global market. The most common types of vinegars and their origin are discussed below



Uses

Household and cooking uses. Apple cider vinegar uses include cleaning, washing hair, preserving food and improving skin function. It can also be used in all sorts of recipes, including salad dressings, soups, sauces, hot drinks and more. Vinegar has many health benefits such as it acts as antimicrobial, antioxidant and antidiuretic. It also helps in reducing cholesterol levels, in controlling blood sugar levels, in replace unhealthy sodium and combat diabetes, in weight loss and cardiovascular diseases. Vinegar is used as preservative in food industry. The other application areas of vinegar are cleaning and hygiene and agriculture.

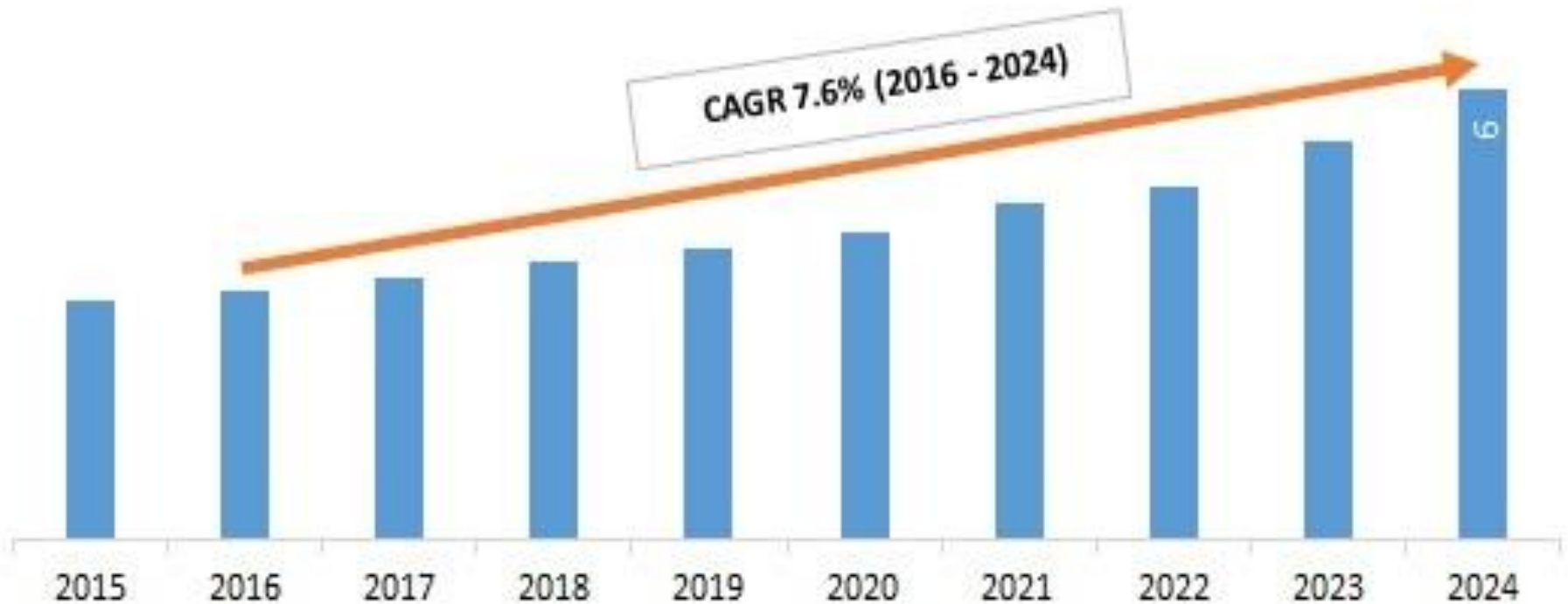


Market Outlook

The global vinegar market reached a value of US\$ 1.3 Billion in 2018. Vinegar refers to an acidic liquid which is produced by the fermentation of ethanol. It is characterized by a sour taste and is rich in vitamin B-1, riboflavin as well as mineral salts. It is widely used as a marinade, preservative and flavor balancer in the food industry. Apple, coconut, malt, cane, lemon and fig are some of the most common flavors of vinegar available in the market. In recent years, there has also been an increase in the demand for gluten-free and organic vinegar products among health-conscious consumers. A significant rise in the demand for ready-to-eat food products has been witnessed owing to factors such as busy schedules, changing dietary patterns and increasing disposable income levels.

This trend is strengthening the market growth. Moreover, wood vinegar is extensively used by farmers for improving seed germination, soil enrichment and root growth stimulation. Owing to these factors, the market is expected to reach a value of US\$ 1.4 Billion by 2024, expanding at a rate of 1.1% during 2019-2024.

Vinegar has many health benefits such as it acts as antimicrobial, antioxidant and anti-diabetic. It also helps in reducing cholesterol levels, in controlling blood sugar levels, in replace unhealthy sodium and combat diabetes, in weight loss and cardiovascular diseases. Vinegar is used as preservative in food industry. The other application areas of vinegar are cleaning and hygiene and agriculture.

There are many types of vinegar such as are White Vinegar, Apple Cider Vinegar, Wine Vinegar, Balsamic Vinegar, Rice Vinegar, Cane Vinegar, Beer Vinegar and Raisin Vinegar. Currently, Balsamic vinegar dominated the market followed by red wine vinegar, cider vinegar and white vinegar.
