To finish the process, the mixture needs to be poured over a container of ice cubes and stirred until it reaches room temperature. The final product should have a clear appearance, with a light yellowish color.





The process for making ginger powder is similar to that of making ginger oil. The only difference is that instead of being heated with vegetable oil, it's dried out at lower temperatures and ground into a fine powder. Once made, the ginger oil and ginger powder will last up to one year when stored in a cool place (refrigerator). These two ingredients are versatile and can be used in many different types of recipes.



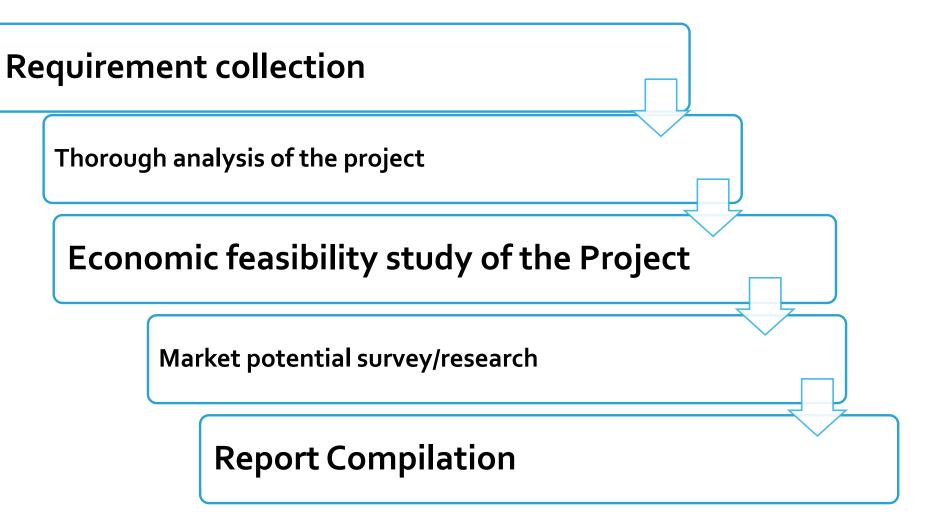

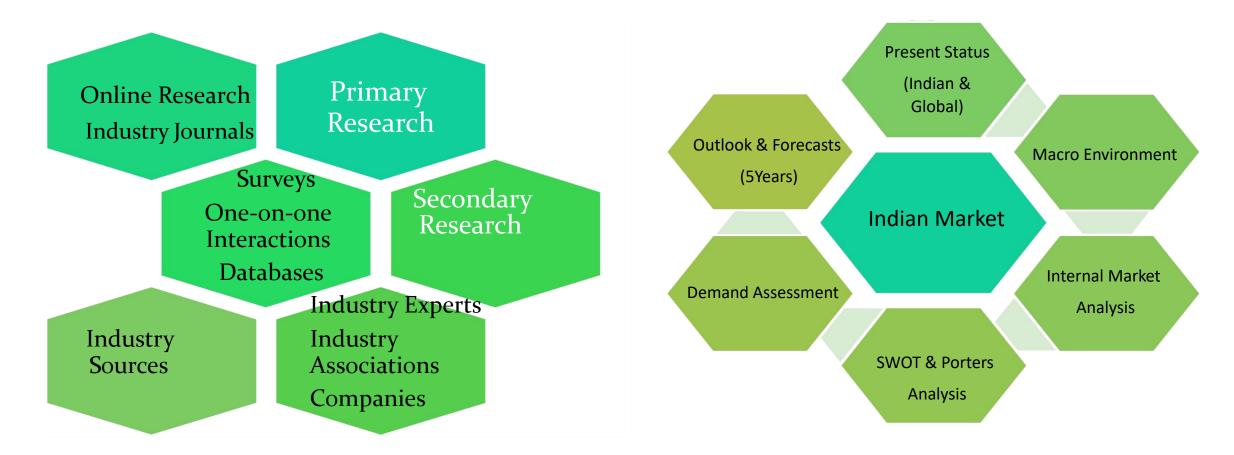
