Introduction

Paprika oleoresin (also known as paprika extract or oleoresin paprika) is an oil-soluble extract derived from the fruits of Capsicum annuum or Capsicum frutescens that is largely used as a food colourant and/or flavouring. It's made up of vegetable oil (usually between 97 and 98 percent), capsaicin (the main flavouring element that gives it pungency in higher quantities), and capsanthin and capsorubin (the main colouring compounds) (among other carotenoids).





It's a lot milder than capsicum oleoresin, and it usually doesn't have any capsaicin at all. Percolation with a number of solvents, primarily hexane, is used to extract the material, which is then removed before usage. After that, vegetable oil is applied to ensure a consistent colour saturation. Many popular foods include the oleoresin paprika, which is sometimes referred to as paprika oleoresin on labels.

Uses of Paprika Oleoresin

Because it's a natural colouring ingredient, the food sector uses it to keep their labels clean. It is used in the cosmetic sector since it has extremely few adverse effects when compared to synthetic substances. It is used in the pharmaceutical business because of its anti-inflammatory effects.

- It is mostly used in food as a colouring and flavouring agent.
