Manufacturing Process

The creation of this concrete mixture is the first step in the LRPC production process. After the concrete has been made, it is poured into a mould to set. After that, the strand is put inside the mould to cure. Hydraulic jacks are utilized to compress the strands after the curing process. Depending on the project they are being used for, these strands are often compressed at various amounts. For instance, only 200 tonnes per metre of pressure may be used for shorter spans or lighter loads, whereas 600 tonnes per metre of pressure may be applied for longer spans or heavier loads.


